# Open Letter of 18 non governmental environmental and consumer organisations from 14 European countries and EU level

Dear Mr. Pötter,

You are certainly aware, pesticide residues are a top concern of European consumers regarding food risks[1]. Earlier this year your company started to introduce measures in order to reduce pesticide residues in fresh food sold by Lidl in Germany. According to our information, Lidl installed an extended quality control system and a new standard that limits pesticides residues in fresh produce to 1/3 of the current maximum residue limits in Germany. Lidl also started to sell organic food and fair trade products in all German shops. In addition Lidl announced to sell QS[2] certified food from the QS program which is monitoring pesticides residues as well. A further step undertaken by Lidl in Germany early October this year was the (preliminary) phase out of conventionally grown table grapes due to high pesticide residues consistently found in this product.

Unfortunately, it is our understanding that this program is limited to Lidl in Germany at the time being, while pesticides residues in food are found above the legal thresholds in all European countries and for many different commodities of plant origin[3].

That is the reason why we ask you for measures and standards in all countries where Lidl is selling food in order to reduce pesticides residues in food.

We ask your company to sell food free of pesticide residues as soon as possible and to implement at least the same standards and measures to reduce pesticide residues already implemented in Germany and to offer organic and Fair Trade food products all over Europe immediately.

In response to growing consumers concerns about pesticide residues in food and the hazards posed by pesticides to consumers, farmers and the environment, several supermarket chains all over Europe are implementing policies to reduce residues and increase the range of organic and Fair Trade products in their shelves already. We believe this is a good way forward and sincerely hope that Lidl does not miss this opportunity to promote pesticide use reduction.

We are looking forward to your response and are totally available to meet you and exchange ideas for cooperation.
