**Biography**

### **François Veillerette, PAN Europe President**

Francois is French and has a teacher education and is the Director of Générations Future (PAN France) which he co-founded and of which he was President for 10 years. He has also been the Vice President of the Picardy region in France in charge of environment, food and health from 2010 to 2015.

Francois is involved in the issues of environmental health and was among other things:

- Founder and Chairman of the Movement for Rights and Respect of Future Generations (MDRGF - now Générations Futures) from 2000 to 2009, he is currently the spokesperson and Director.
- Board Member and current President of the European network Pesticide Action Network (PAN Europe)
- Member of the Steering Committee of the International POPs Elimination Network (IPEN)
- Current member of the Writers Association of Journalists for the Environment (JNE)
- Former president of Greenpeace France from 2003 to 2006 and then Vice- President of the same NGO in 2008-2009.
- Francois also co founded the Réseau Environnement Santé (RES) in France.

### **Paul Francois**

I started working at the age of 15 on the family farm. In 1987, I settled on 30 hectares (parallel to the family farm) and in 1991, I cultivated 230 hectares of cereals in very intensive agriculture, based on chemistry. At the end of the 1990s, I formed a cooperative of material and employees with a neighbor, making a total of 400 hectares to cultivate.

In the organization of work, I mainly deal with planting and spraying of plant protection products (3 treatments (fungicides, herbicides, insecticides) twice a year, for a total of 3,000 hectares per year). In 2004, I was poisoned with a herbicide, Lasso, which led to my hospitalization and 5 weeks of work stoppage. In November of the same year, my state of health deteriorated: 5 months of hospitalization and 9 months of work stoppage.

I restarted my activities in July 2005 and after a refusal of recognition of occupational disease from the Mutualité Sociale Agricole (MSA), I began a procedure before the courts. In 2010, after 5 years of battle, I was recognized as having a professional disease by the Bordeaux Court of Appeal, which recognizes Lasso's responsibility in my health problems.

In 2007 and in parallel to my procedure of recognition in occupational disease, I decided to attack Monsanto in court. Monsanto was condemned for the first time in 2012 by the Court of Appeal of Lyon. In September 2015, the High Court of Lyon condemns on appeal and a second time the American firm. At present, I am awaiting the decision of the Court of Cassation, which will have to fix the amount of damages suffered.

Professionally, I decided to convert 100 hectares of my farm to organic prioritizing plots close to residents and public places. The goal is to convert my entire farm to organic before 2020.

The association Phyto-Victimes was created in March 2011, along with several other farmers also poisoned by pesticides. We help professionals who are victims of pesticides, especially by accompanying them in their efforts to recognize occupational diseases. At the present time, we have about 250 files of professionals who are victims of pesticides. We also do prevention in agricultural colleges and among the general public to inform the greatest number of people of the danger of pesticides and alternative solutions to pesticides

In addition, we have been cooperating for many years with the public authorities in order to reform legislation on the authorization of pesticides and on regulation in general ...

Currently, the association has a proposed law, introduced by Senator Charentaise Nicole Bonnefoy, to create a compensation fund for the victims of pesticides abounded by the firms. The association has more than 300 members and donors

### **Marie-Thérèse Gillet, Fernelmont, Belgique**

Marie-Thérèse Gillet has lived in the countryside for 70 years. She is therefore not frightened by the slightly muddy roads or rugged terrain. However, for some time she has been fighting two cancers. The municipality of Fernelmont, where she resides, is surrounded by agricultural land and inundated by the spraying of pesticides. In addition to her own, she noticed an abnormally high case of cancers in his neighborhood: 20 of which 8 in the same street. For the past eight months, Marie-Thérèse has been carrying out various actions to challenge local authorities and the population on this subject so that preventive measures are put in place such as buffer zones. The local and regional authorities are launching investigations but have not been taking into account the actual figures for cancers and other pathologies. Today, Marie-Therese is coming to tell us the story of her commune.

### **Camilla de Nardi**

Camilla is currently attending a Master course in Human Ecology and Sustainability at the University of Gastronomic Sciences in Italy. She is also doing an internship at PAN Europe, mainly focusing on the project Voices of Pesticides and a campaign in Veneto (Italy) that aims at minimizing the harmful impact of pesticides on the environment and human health. Camilla is doing her final thesis based on the research led in Veneto, field observations and interviews done with the local people. During her presentation, she will sum up the findings of her research, highlighting the current local situation in Veneto and in prosecco vineyards, by reporting some victims of pesticides' stories.
