

# BANNED EU PESTICIDES EXPORTED TO SOUTH AFRICA

## MAIN PESTICIDE ACTIVE SUBSTANCES EXPORTED TO SOUTH AFRICA

### 1,3-DICHLOROPROPENE

Soil fumigant used in fruit and vegetable crops.

It has been banned in the EU since 2007 due to **concerns about groundwater contamination, consumer exposure, risks to mammals and aquatic organisms, and possible impacts on non-target organisms.**

In 2024, 1,3-D was the most exported pesticide from the EU, with 810 tonnes shipped to South Africa

### EPOXICONAZOLE

An azole fungicide used on various crops (including cereals, soy, and sugar beet).

It has not been authorised in the EU since 2020. Its producer, BASF, withdrew its license renewal application in anticipation of a ban due to its toxicity. Already in 2016 certain issues were highlighted: unresolved risks to some animal species and the environment, incomplete data on triazole metabolites (TDMs), potential endocrine-disrupting properties, and uncertainties regarding long-term exposure for users and consumers.

It is included on the **PAN International Highly Hazardous Pesticides (HHP) list**. Different classifications reflect similar concerns regarding its potential carcinogenic and reproductive risks: it is classified as a **probable/likely carcinogen** by the EPA, and under the EU harmonised classification it is listed as **Carc. 2 "suspected of causing cancer", Repr. 1B "may damage fertility or the unborn child", and Aquatic Chronic 2 "hazardous to the aquatic environment"**.


### CYANAMIDE

Used in particular as a growth regulator or herbicide.

It has been banned in the EU since 2008 due to health concerns: "it may **be expected that it has harmful effects on human health**, in particular for operators," as well as concerns regarding **acute and long-term risks to small herbivorous mammals.**

It is included on the PAN International HHP list and is classified under the EU harmonised classification as **Carc. 2 "suspected of causing cancer" and Repr. 2 "suspected of damaging fertility"**.



### OTHER DANGEROUS SUBSTANCES THAT ARE EXPORTED FROM EUROPE TO SOUTH AFRICA ARE:

- **Neonicotinoid pesticides** (imidacloprid, thiamethoxam, clothianidin, thiacloprid): These substances are **neurotoxic and highly toxic to bees and pollinators**. They were banned in Europe as it was demonstrated that their use contributed to the collapse of bee colonies. Because of their neurotoxic mechanism of action we now find they may harm brain development in children and fetuses during pregnancy. Thiacloprid is classified as toxic to reproduction Category 1B.
- **Dithiocarbamate (DTC) fungicides (mancozeb, propineb, thiram):** Mancozeb is classified in Europe as **toxic to reproduction 1B and is an endocrine disruptor**, as it affects thyroid function. This means it can have an impact on early life development, posing a high risk for pregnancies and children. DTC pesticides break down to a common and very harmful metabolite ethylenethiourea (ETU), which has been shown **to cause birth defects, brain malformations and cancer in laboratory studies.**
- **Propiconazole:** another azole fungicide which was banned in Europe as it was shown that is toxic to reproduction and can contaminate water resources, including groundwater. Issues were raised in relation to its endocrine disrupting properties and consumers' protection.


