Why do EU countries block a ban on PFAS and Endocrine Disrupting pesticides?

The EU doubts and hesitates. Still, no ban is proposed for the most frequently found PFAS endocrine disruptor in fruit and vegetables. It is high time to break this weakness and take highly necessary steps to protect health and biodiversity. On 9 and 10 July 2025, the Pesticide Committee (SCoPAFF) will gather once again to discuss whether to finally take action on PFAS and endocrine-disrupting pesticides. <u>Read more</u>

Glyphosate causes cancer at EU "safe" exposure levels

A new, groundbreaking research shows that exposure to glyphosate and glyphosate-based herbicides can cause cancer in laboratory animals at doses deemed "safe" by EU authorities. This might force governments to review



their support for the world's most popular weedkiller. The critical evidence was ignored during glyphosate's reapproval process, resulting in its reapproval for another ten years. PAN Europe and its members fight this decision in the EU court. The findings of the study directly contradict EU risk assessors' conclusions and raise serious concerns about the adequacy of current safety standards and compliance with EU law. <u>Read more</u>



EU re-approval of toxic cypermethrin unlawful?

The Advocate General of the Court of Justice of the EU concluded that the European Commission acted unlawfully by re-approving the insecticide cypermethrin. There are major toxicity data gaps in the reapproval dossier; it

relies on non-validated and unrealistic risk mitigation measures, and it disregards toxicity to insects. The Advocate General agrees with many arguments put forward by PAN Europe in this appeal case against the EU re-approval. In most cases, the EU Court of Justice follows these conclusions. <u>Read</u> <u>more</u>

Co-formulants: the Black Box of pesticides' toxicity

We took part in a hearing at the General Court of the EU in Luxembourg, questioning the lack of testing of co-formulants in pesticide products. We initiated this legal case in 2023. Co-formulants represent the majority of the ingredients of commercial pesticides. Usually, only one active ingredient is assessed for its toxicity to humans. Co-formulants are currently very poorly monitored and regulated. Read more
