This will now be revised, but there is no insect expert in the EFSA working group. In some countries, dangerous pesticides are on sale in garden shops, such as Belgium and the Netherlands. Over 450 scientists rally for immediate action against 'forever chemicals' in EU waters. Romanian court stops illegal derogations for neonicotinoids. Researchers prove that pesticides contaminate a landscape scale, far beyond the fields. And we highlight the dangers of acetamiprid, the brain-toxic neonicotinoid we must urgently leave behind.

#### No insect expert in EFSA working group on new guideline

The EU is reviewing a guidance document meant to protect insects and other arthropods against the negative effects of pesticides. The current document is outdated and was co-written by the pesticide industry. It has never led to a



ban on pesticides that contribute to Europe's staggering loss of its insect biomass and its farmland bird populations. Read more



#### Dangerous pesticides sold to the general public in Belgium and the Netherlands

Karate, Delete, trade names for highly toxic pesticides sold to individuals online and in garden shops in Belgium and the Netherlands. The neurotoxic deltamethrin, the neurotoxic beekiller acetamiprid (in Belgium) and the PFAS pesticides lambdacyhalothrin and flupyradifurone. Where farmers are obliged to follow a training for a

spraying licence, inexperienced citizens are enticed to spray these products, sometimes directly on the vegetables in their garden. What is the situation in your country? Read more

#### Romanian court puts an end to derogations for neonicotinoids

The Romanian Court of Appeal suspended new derogations for the use of neonicotinoid-treated seeds in maise and sunflowers. This is the result of a court case by Eco Ruralis and our member Romapis to protect pollinators.

#### Urgent action needed: TFA contamination in Europe's water

We organised a high-level event at the European Parliament to address the global threat to drinking water. Leading experts and policymakers discussed the environmental and public health risks all over Europe posed by Trifluoroacetic acid (TFA), a highly persistent breakdown product of several chemicals, especially PFAS pesticides. #### Pesticides contaminate on a landscape scale - far beyond the fields

A new, groundbreaking German study proves that pesticides spread much further from the field than previously believed. A team led by Professor Dr. Carsten Brühl tested topsoil, vegetation, streams and puddles over a 180 km stretch, from remote areas in the UNESCO forests on the mountain ranges to the farmland in the Upper Rhine area. They detected pesticides at every location, 63 in total. Read more

EU Member States agreed to ban the endocrine-disrupting PFAS pesticide flufenacet. We applaud this decisive action, which aligns with the EU's requirement to protect human health and the environment. Comprehensive action on all PFAS pesticides is urgent to avoid the use of similarly problematic substitutes. Read more

Neonicotinoid insecticides pose a serious threat to biodiversity and human health. Already in small doses, they can affect the developing brain of young children. France would like to reintroduce acetamiprid, while we asked the EU

#### Pesticide Free-Day in the Netherlands on World Parkinson's Day

Friday, April 11, is World Parkinson's Day. Leading experts warn of a Parkinson's epidemic, and toxic chemicals and especially pesticides, play a major role. Pesticides are hardly tested for neurotoxic effects and not at all for the mechanisms that cause Parkinson's. Farmers and consumers are, in fact, misled by false safety claims by producers and authorities. The Dutch Parkinson's Association, Natuur & Milieu, trade

#### Spain exported 17,000 tons of pesticides banned in the EU in one year

Spain authorized the export of nearly 17,000 tons of substances harmful to

people and the environment in 2023, mainly to the Global South. This is exposed in the new report 'Double Standards, Double Risk'. Read more here. And PAN Netherlands started a new campaign to Stop the export.

## Italian Doctors for the Environment warn of the dangers of glyphosate use

Our Italian member, ISDE - Doctors for the Environment - warned in a hearing about the dangers of using glyphosate in Vercelli, in the Piedmont region. The



City Council is considering its use for urban weed control despite scientific evidence linking glyphosate to cancer risks and environmental harm. ISDE President Elena Uga called it an "unacceptable threat" to public health and biodiversity. Italy had already banned glyphosate in recreational areas, playgrounds, parks, or places where vulnerable groups can be affected and in private gardens. Read more
